### What We Do

Nebraska Right to Life sponsors the annual Nebraska Walk for Life, State Fair booth and outreach to county networks with educational materials, including a free-lending book and DVD library. NRL maintains a social media presence across multiple formats.

The annual Nebraska Walk for Life commemorates the landmark Supreme Court decision, Roe vs. Wade, January 22, 1973. It is the largest, longest running First Amendment demonstration against abortion in the state. Participants gather at the State Capitol and walk several blocks to an indoor venue to hear a nationally known speaker deliver a profound prolife message. Thousands of pro-life supporters have gathered for this event since its inception in 1974. NRL also marks the day by distributing roses to state senators and constitutional elected officials at the State Capitol.

NRL lobbies on state and federal legislative issues with alerts and outreach to grassroots supporters. Our lobbying and testifying efforts are evident at the State Capitol with prioritization of pro-life bills.

NRL hosts an annual Pro-Life Legislative Day at the Capitol to train and engage citizen lobbyists to talk to their state senators about legislation. We also work with a coalition of other groups to stop Planned Parenthood from expanding into other areas.

NRL's Political Action Committee is responsible for surveying, interviewing and endorsing candidates for state and federal office. NRL's PAC then distributes thousands of voter guides

## Who We Are

Nebraska Right to Life (NRL) was founded in March 1973, three months after the Supreme Court's Roe v. Wade ruling. It is the largest grassroots, longest-running statewide pro-life organization in Nebraska. This nonpartisan, nondenominational organization is composed of pro-lifers whose passion is to protect the most innocent and vulnerable among us. As such, NRL's grassroots activists are the voice of the pro-life movement in their communities across the state.

We work on policies to oppose abortion, infanticide, euthanasia and unethical biomedical research, and we work to promote a culture of life.

The ultimate goal of Nebraska Right to Life is to restore legal protection to innocent human life.

It is our belief that this goal can only be achieved through a unified, statewide educational and legislative effort that is coordinated with an effective national program.

Nebraska Right to Life is the state affiliate of the National Right to Life Committee in Washington, D.C. NRL and its local chapters adhere to the philosophy of National Right to Life Committee. A Nebraska Right to Life board member represents Nebraska pro-lifers on the National Right to Life board.

We are committed to working through legal, peaceful means to effect change, in state and federal legislation, education and political action. This commitment is derived from a belief that each human being, from the time of fertilization to natural death, has an immeasurable dignity and unalienable right to life. Elemental justice demands that this basic right be protected by law

NRL is governed by a board of directors composed of members from across the state of Nebraska. NRL collaborates on activities with chapters. In particular, NRL supports and oversees educational activities in order to foster a true respect for all human life; initiates and supports political, legal and legislative efforts so that the full

protection of the laws of our state and nation will once again be afforded to all human beings; and coordinates Nebraska pro-life activities with those of other states and the nation as a whole.

In addition to maintaining a lobbying presence at the state level, Nebraska Right to Life serves as a clearinghouse of information for its local chapters, its individual members, the press, and the public.
