ABORTION

Nebraska Right to Life holds that unborn children should be protected law, and that abortion should be permitted only when necessary to prevent the death of the mother. Under what circumstances, if any, do you believe abortion should be legal?

- 1A. Only to prevent the death of the mother (NRL position)
- 1B. To prevent the death of the mother, or in cases of rape reported to a law enforcement agency, or incest against a minor reported to a child abuse agency
- 1C. Other: Please explain below

HEARTBEAT PROTECTION ACT

Heartbeat Protection bills would protect unborn children from abortion when an unborn child's heartbeat is detected (with exceptions for the life of the mother). Heartbeat Protection bills require doctors to check for a fetal heartbeat before performing an abortion. As with all of NRL's legislation, women who obtain an abortion that violates this law would not be subject to prosecution. A number of states have passed bills based on protection a child once a heartbeat is detected.

- 1D. Would you support legislation to protect unborn babies from abortion from the point in development at which an unborn child has a detectable heartbeat?
- 2. Planned Parenthood is the largest provider and promoter of abortion in the U.S. Would you support efforts to divert tax funds for government programs away from Planned Parenthood and any such organizations which perform, promote, counsel or refer for abortion?
- 3. Abortion clinics in Nebraska are largely unregulated. Would you support requiring abortion clinics to meet the same public health standards as other out-patient surgical facilities?
- 4. Would you oppose taxpayer funding of school-based health clinics in public schools which would counsel and refer for abortion without parental consent?

Note: For Question 5, the term "use" means: "the sale, purchase, research and/or transplantation of."

- 5. Would you support banning the "use" of human embryonic stem cells, either multiple frozen embryos created through in vitro fertilization or embryos created for the express purpose of medical research?
- 6. Do you oppose physician-assisted suicide?
